Patrick reviewed what riders should do immediately after a crash if at all possible:

1. Get to safety.
2. Always contact the police and try to get an official accident report.
3. If local police refuse to respond then be calm, record the call, but still do anything reasonable to try to convince them to respond.
4. Get the medical treatment that you need.
5. Call an attorney.
6. You are never required to speak to an insurance company directly. If you have an attorney, let the attorney do that for you.
7. If you are in a group or have witnesses, try to get pictures and statements.

Provided advice on insurance coverage:

- Carry uninsured and underinsured coverage
- Get as much coverage as you are allowed and can afford.

Law Tigers attorneys work only on contingency. If you hire them, you only pay if they win money for you.
